General Terms & Conditions of Tender

Note: These Terms & conditions should be read very carefully by the tenderers while filling in their tender.

- 1. Tenders must be enclosed in properly sealed envelopes according to the directions given in the tender notice.
- 2. The rates must not under any circumstances be altered and must be entered in words as well as in figures.
- 3. All rates quoted must be F.O.R. Unit destination and should include all taxes and shall properly packed to avoid damage/leakage, breakage etc. and shall be in good condition. Loss caused due to this account shall be borne by the firm.
- 4. The rates quoted shall be valid for one year i.e. from 15.07.2025 To 14.07.2026.
- 5. Tender should be filled legibly. No additions/alterations should be made in the tenders. Correction, if any, should be done legibly and initialed. No overwriting is permitted. The tenderer should sign tender at each page in token of the acceptance of all the terms and conditions of the tender and agreement.
- 6. The tender without earnest money shall not be considered.
- 7. Successful tenderer will have to execute an agreement on non-judicial stamp paper of Rs. 500/-.
- 8. Direct and indirect canvassing on the part of tenderers or their representatives will disqualify their tenders.
- 9. The competent authority reserves the right to accept any tender not necessarily the lowest tender and reject any tender without assigning any reason.
- 10. Negotiation with Ist lowest tenderers to reduce the rates etc. may also be conducted if required .
- 11. The work of pest control shall be of the best quality and in case Pest Control work is not found up to the mark, deduction shall be made accordingly.
- 12. All legal proceeding if necessity arises by any of the parties (Corporation/ Contractor) shall have to be lodged in the courts situated in Jaipur only.
- 13. The tenderer shall be not assign or sub let his contract or any substantial part there of to any other agency.
- 14. The tenderer will have to render pest control services four time in a month i.e. weekly.
- 15. The security amount @ 5% from each bill shall be deducted for the due performance of the contract. It will be refunded after two months from the date of satisfactory completion of the period of rate contract. No interest shall be paid on the security money.
- 16. When the approved contractor fails to work up to the satisfaction or to provide the pest control services in the specified period, the unit incharge shall be at liberty to get the work done from the open market at the risk and cost of the approved contractor and the difference if any, shall be recovered from approved contractor from the security or any pending dues.
- 17. The General Manager, Hotel Gangaur, Jaipur reserves the right to forfeit the earnest money if the contractor fails to execute the agreement or commence the supply. The earnest money stand converted into security money.

- 18. The General Manager, Hotel Gangaur, Jaipur also reserves the right to forfeit the security deposit pending in case any breach of any provisions of agreement by the suppliers.
- 19. The tenderer shall invariably furnish complete address of the premises of his office, godown and workshop where inspection can be made together with full name address of the person who is to be contacted for the purpose.
- 20. Tender must be accompanied by earnest money as mentioned on the tender form. Without earnest money tenders will not be considered. The earnest money either be deposited in cash or through demand draft in favour of General Manager, R.T.D.C. Hotel Gangaur, Jaipur.
- 21. General Manager, R.T.D.C. Hotel Gangaur, Jaipur. reserves the right to cancel the tender without assigning any reason.
- 22. The tenderer will ensure 100% eradication of Mosquitoes, flies cockroaches Moles ect. by effective treatment and timely sprays.
- 23. The tenderer will ensure deployment of skilled and responsible staff for the pest control service in the hotel. The rooms will be given for spray and treatment as and when available which may take two to three days time. The spray in kitchen, pantry, dining hall and raw material store can be done in the night hours after 11 P.M. During the treatment of these areas due precautions will have to be taken to protect the food items from contamination.
- 24. Any type/ kind of lodded to the guest/ staff of the hotel due to pest control service or by your staff shall be borne by the successful tenderer.
- 25. Tender should be given by those firm/dealers who are registered/ approved for stock and use of restricted insecticides for certificate about the trade in which they are dealing.
- 26. T.D.S. if applicable will be deducted from the payment of bill of pest control services.
- 27. No other terms and conditions except these mentioned, above will be entertained in the tender.
